- Location:** 11201 Harrell Street

- Service area:** 48-square mile region of western Riverside County, including the City of Eastvale and the City of Jurupa Valley.
- Governance:** Jurupa Community Services District (JCSD) is a public agency of the State of California, known as a Special District, governed by a five member, elected, Board of Directors.
- Purpose:** JCSD is responsible for providing water, sewer and street lights for over 101,000 people and for maintaining more than 160 acres of parks and over 40 miles of frontage landscape.
- Facilities:** JCSD facilities consist of 18 wells, 15 water storage reservoirs with a total capacity of 45 million gallons and 9 booster stations.

- History:** **1956** – JCSD Established for the purpose of installing a sewer system within Jurupa.  
**1958** – General obligation Bonds issued to fund construction of a sanitary sewer system and sewage treatment plan.

- 1961** -- Construction completed and the District began providing sewer services.
- 1963** – Water Revenue Bonds issued for the acquisition and improvement of water facilities, including three existing water companies: The Jurupa Heights Water Company, La Bonita Mutual Water Company and Monte Rue Acres Mutual Water Company.
- 1966** – Bonds issued to finance the purchase of the above companies.
- 1972** – Rubidoux Community Services District, JCSD and The City of Riverside receive a State and Federal mandate to consolidate all wastewater treatment facilities into one location, now the existing Riverside Treatment Plant.
- 1978** – Mira Loma Water Company acquired by JCSD.
- 1986** – Felspar Gardens Mutual Water Company now served by JCSD.
- 1988** –Community Facilities District No. 1 formed to provide water, sewer, flood control and street infrastructure within the Mira Loma area.
- 1990** – JCSD enters into an agreement with the Jurupa Public Facilities Corporation to purchase additional capacity in the City of Riverside Water Quality Control Plant and to purchase capacity in the Santa Ana Regional Interceptor (SARI).
- 1997** – JCSD consolidates the Mutual Water Company of Glen Avon Heights.
- 2001** – JCSD enters an installment purchase agreement with the California special Districts Finance Corporation to purchase current headquarters building on Harrel St. and to construct the Roger Teagarden Ion Exchange Water Treatment Facilities.
- 2007** -- Ordinance 280 was adopted with a four year water rate restructuring plan.
- 2010** -- Sunnyslope Reservoir was built, providing 12 million gallons of additional water storage, making it the largest reservoir in the JCSD service area.
