Keeping JCSO Customers in the Know and Updated...

JCSO's Defense in the Ongoing Litigation with the City of Riverside

The Jurupa Community Services District (JCSO) has continuously requested the City of Riverside (Riverside) to withdraw its litigation against JCSO. JCSO has offered in good faith to negotiate a resolution fair to all ratepayers; however, Riverside continues to deny our request resulting in exploding legal costs for both agencies over the past year.

The Issue

Riverside claims in the litigation that JCSO is liable to

pay for a portion of the current \$250 million contract to upgrade the wastewater treatment plant (plant) that serves Riverside residents as well as Jurupa, Rubidoux, and Edgemont Community Services Districts (CSDs). Riverside has refused to negotiate with JCSO to resolve the issue and instead is using litigation to reinterpret a long-standing agreement (established in 1990) that was negotiated the last time there was a dispute about plant upgrades. The agreement limits JCSO's payment to plant upgrades for regulatory compliance mandates, which is how the agreement has been consistently applied over the past 23 years. Both Riverside and JCSO have cooperatively worked together for nearly 37 years in the operation of the plant. Equally important, JCSO's

Water Saving Program for Local Businesses

Local businesses can receive free high-efficiency urinals through a program offered by Western Municipal Water District (WMWD). The purpose of the program is to conduct a study on high-efficiency urinals in the commercial sector. WMWD will replace up to 2,000 high-water-usage urinal valves with high-efficiency valves that only use 0.5 gallons of water per flush.

There is no cost to participating commercial/industrial businesses and can help a business reduce urinal water usage by up to 70 percent. The program is open to businesses in the JCSD service area. If your

ongoing requests for Riverside to suspend litigation pending good-faith negotiations will protect ratepayers' wallets from unnecessary litigation expenses while the dispute is resolved. Currently, both agencies have spent approximately \$200,000 each on litigation costs.

In a decision made by Riverside in 2006, the plant is being converted to a costly type of treatment process called a Membrane Bioreactor (MBR). MBR has been used in small plants, because of higher costs to operate, and not larger plants like Riverside. No other MBR plants on this scale have been built and proven effective in California. Recently, MBR plants on a large scale are being constructed in luxury locations such as Dubai, Oman, and Las Vegas. MBR uses up to 25% more electricity to operate compared to the tried-and-true conventional treatment process used at the Riverside plant for decades and simply is unnecessary for the City's and the CSD's needs. The existing

plant currently meets all federal, state and local requirements and into the foreseeable future. JCSD recognizes its financial responsibility under existing agreements to pay for the replacement of facilities as part of ordinary maintenance. But this is much different than being forced to pay for a massive and unneeded conversion of the plant's existing facilities which already meet regulatory standards.

The lawsuit overlaps major issues in our community. The financial viability of the Cities of Jurupa Valley and Eastvale are awaiting outcome of SB 56, a Senate Bill aimed at restoring millions of funds lost by these cities as a result of funds diverted by state lawmakers. The City of Jurupa Valley is entangled in a legal defense regarding the Riverside Transmission Reliability Project. This Project will support the additional electricity needed to support the questionable MBR treatment process. Both Jurupa Valley and Eastvale have current and future sewer system needs

whose costs are in addition to impacts from the Riverside litigation. Riverside's \$250 million MBR plant renovation coupled with its attempt to force extraordinary cost participation from JCSD adds more unnecessary costs. JCSD recognizes the importance of balancing infrastructure needs with costs and is working diligently to work through these issues for our customers.

Impact to Ratepayers

Initially, the minimum impact to current sewer rates for all JCSD customers is 10%, with future impacts potentially doubling that amount. Additionally, the MBR process chosen by the City of Riverside requires greater use of electricity and increases operational costs which ultimately result in even greater rate increases in the future.

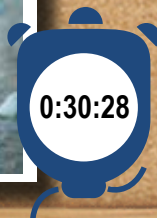
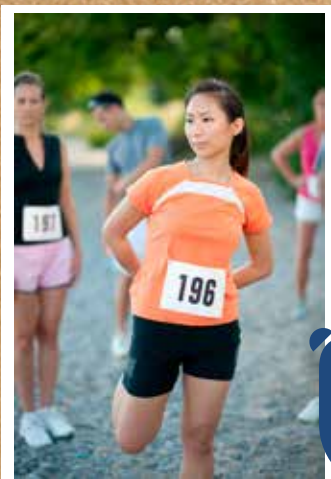

Upgrades to Community's Infrastructure Continues on Felspar Street and Surrounding Roads

As part of our ongoing commitment to provide quality service, JCSD will continue a series of capital improvement projects within our service area in the City of Jurupa Valley. The Pyrite Creek Sewer Project includes major construction in order to upgrade or improve the community's sewer system infrastructure.

Stage 1 of the project has been completed which included the necessary closure on Limonite Avenue between Bain Street and Beach Street. This portion of the sewer construction project was completed on time and Limonite Avenue opened as scheduled on July 2. JCSD would like to again thank the community and the City of Jurupa Valley for a successful closure.

Part of Stage 2's construction took place on Limonite Avenue between Beach Street and Felspar Street. Construction began on July 8, with an anticipated completion date of mid-September. Stage 2 of the construction continues. Below is the anticipated schedule:

Approximately from July 24, 2013 – September 15, 2013

cle, Cliff Valley Circle, and 56th Street.

Approximately September 17, 2013 – May 2014

Sewer pipeline construction will be taking place on Felspar Street, 58th Street, Big Meadow Road, and Cliff Valley Circle.

Numerous speed limit signs have been placed in the construction zone to alert motorists to slow down. Additional Riverside County Sheriff's Department traffic patrol and public safety enforcement have been assigned to patrol the construction zone.
