

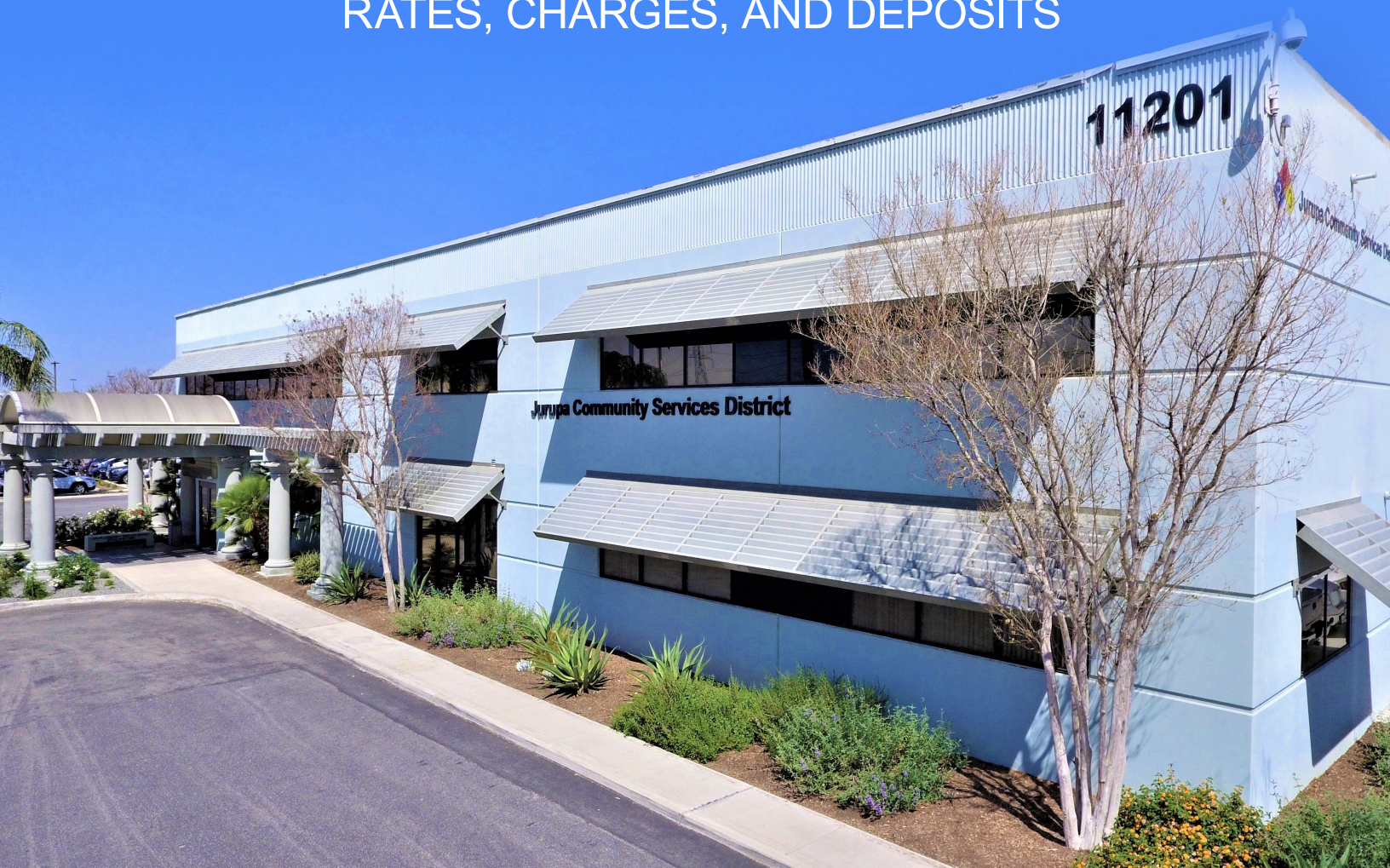

Rate Structure	Charge
Monthly Base Charge per EDU:	\$26.18
*Usage Rate Per HCF Charge Per Unit:	\$2.70

An **EDU** is a unit of measure for the sewage generated from particular buildings, structures or uses.

\*Maximum usage charge is 8 units for residential and institutional customers.

**MONTHLY BASE CHARGE + USAGE RATE = MONTHLY SEWER CHARGES**

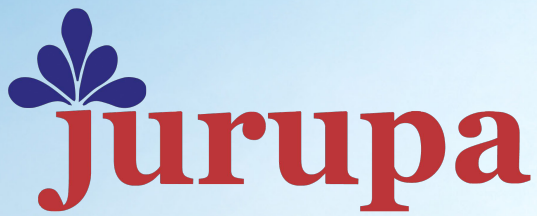
