RESOLUTION NO. 3469

**A RESOLUTION OF THE BOARD OF DIRECTORS OF
JURUPA COMMUNITY SERVICES DISTRICT
ESTABLISHING FEES FOR ITS CROSS-CONNECTION
AND BACKFLOW PREVENTION PROGRAM**

WHEREAS, on December 19, 2023, the State Water Resources Control Board adopted the Cross-Connection Control Policy Handbook ("CCCPH") with an effective date of July 1, 2024, in order to protect a public water system's potable water supply against the introduction of harmful constituents from on-site conditions or uses by customers that create a risk of contamination;

WHEREAS, compliance with the CCCPH is mandatory for all California public water systems, including Jurupa Community Services District;

WHEREAS, on May 27, 2025, the District introduced and held the first reading of Ordinance No. 468, AN ORDINANCE OF JURUPA COMMUNITY SERVICES DISTRICT ADOPTING A REVISED CROSS-CONNECTION AND BACKFLOW PREVENTION PROGRAM ("Cross-Connection Ordinance"), which revised the District's cross-connection and backflow prevention program to conform to the CCCPH;

WHEREAS, on June 9, 2025, the District held the second reading of the Cross-Connection Ordinance and adopted it unanimously;

WHEREAS, the Cross-Connection Ordinance requires annual testing of all backflow prevention assemblies ("BPA");

WHEREAS, under the Cross-Connection Ordinance, the customer will own the BPA and be responsible for all testing, retesting, maintenance, and repair of his or her BPA as well as providing the District with the proper records and test data from the BPA ("Customer's Responsibilities");

WHEREAS, the District offers services in which it will perform the customer's responsibilities at cost to the District;

WHEREAS, the District will perform the Customer's Responsibilities services either at the written request of the customer or if the customer fails to comply with the BPA program and policies;

WHEREAS, the District's performance of the Customer's Responsibilities will be completed by a third party;

WHEREAS, the Cross-Connection Ordinance authorizes the District to implement fees by resolution to cover the costs incurred by the District for the performance of its duties and services under the Cross-Connection Ordinance; and

WHEREAS, the proposed fees were publicly noticed in compliance with Government Code section 66018, in that the notice was published in a newspaper of general circulation twice pursuant to Government Code Section 6062a preceding the public hearing scheduled for June 9, 2025.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE BOARD OF DIRECTORS OF JURUPA COMMUNITY SERVICES DISTRICT AS FOLLOWS:

Section 1. The Board of Directors finds that the above recitals are true and correct and are incorporated by reference herein.

Section 2. The Board of Directors hereby approves and adopts fees for testing, repair, and replacement of BPAs. All fees shall be set at the Cost of Recovery of what the District pays to a third-party contractor to complete the Customer's Responsibilities. The fees for BPA installation, testing, maintenance, repair, and replacement shall be as follows:


BPA Installation Fee	Actual Cost
BPA Testing Fee	Actual Cost
BPA Maintenance Fee	Actual Cost
BPA Repair Fee	Actual Cost
BPA Replacement Fee	Actual Cost

Section 3. The Board of Directors hereby directs staff to procure a responsible third-party contractor in accordance with the District's procurement policy.


